Private FDR and Early Neutral Evaluation

The problem

Delay in awaiting hearings is a regrettable feature of the current court system, inevitably leading to increased cost and stress.

The solution

Private Financial Dispute Resolution appointments (in finance cases) and Early Neutral Evaluations (in both children and finance cases) address this head-on. The basic idea of each is that the parties engage a barrister (or solicitor) of their choosing to read the papers and hear the legal arguments each wishes to present. Then the barrister will express a view as to the court's likely approach were the case to proceed further. The parties then negotiate, informed by the barrister's view. They will usually settle.

In finance cases, an additional benefit of a private FDR is that it replaces the court-based FDR which the parties would otherwise be obliged to attend. The great advantage of the private FDR is that it takes place at a time of your choosing, in comfortable surroundings and with your appointed barrister's undivided attention. Settlement rates are widely considered to be much higher than following a court-based FDR. Private FDRs and ENEs are a suitable and cost-effective option in the great majority of cases, indeed might be thought particularly apt where the costs of continuing litigation are becoming unaffordable or disproportionate.
