

## Family Mediation

Family mediation at 4PB involves a trained and experienced family law barrister mediator who meets with the people involved in a dispute and works with them through a process to steer a path to an agreement about what should happen next. Decisions are made by consensus between the two people involved, on an agenda they set. The mediator can give information to assist, and will ensure that each person's view is heard and investigated.

- Mediation is appropriate for any type of family law matter; divorce, children's arrangements, financial or property matters, child relocation, child abduction, and even in some circumstances where the local authority is involved in the care of a child.
- Mediation is appropriate for most people involved in a family law dispute, but each participant is assessed individually to ensure safety and capacity.
- Mediation is a voluntary process, aimed towards reaching an agreement and avoiding court proceedings. However, the financial disclosure aspect is no less rigorous than it would be in court proceedings.
- Mediation usually takes place with both (or all) the people involved in the same room, but if there are reasons why this is not appropriate it is possible to make arrangements to remain separate during mediation.
- Mediation is confidential
