Profile

Michael is the head of the Public Inquiries and Inquests team at 4pb. He is currently instructed in the Afghanistan Inquiry (for the MOD), the Covid Inquiry (for UKHSA) and the Omagh Bombing Inquiry (for the Intelligence and Security Committee). Michael is a member of the AG's B Panel (previously a member of the C Panel for 5-years).

Michael also has judicial experience. He is a Recorder of the Family Court and child law arbitrator. In 2022, he was appointed to a 3-member judicial panel to determine the asylum claims of Sri Lankan Tamils present on British Indian Ocean Territory.

Michael is a Special Advocate and acts in cases of national security in Closed Material Proceedings.

Michael has also appeared in many of the leading cases on the validity of marriage, including Akhter v Khan [2020] EWCA Civ 122 and AP and IP v Secretary of State for Justice [2024] EWHC 1197 Fam
